
- c) Allowing to install the machinery and equipment which may be required for and effective maintenance and working of facility of Rain Water Harvesting Ground and Water Recharge.

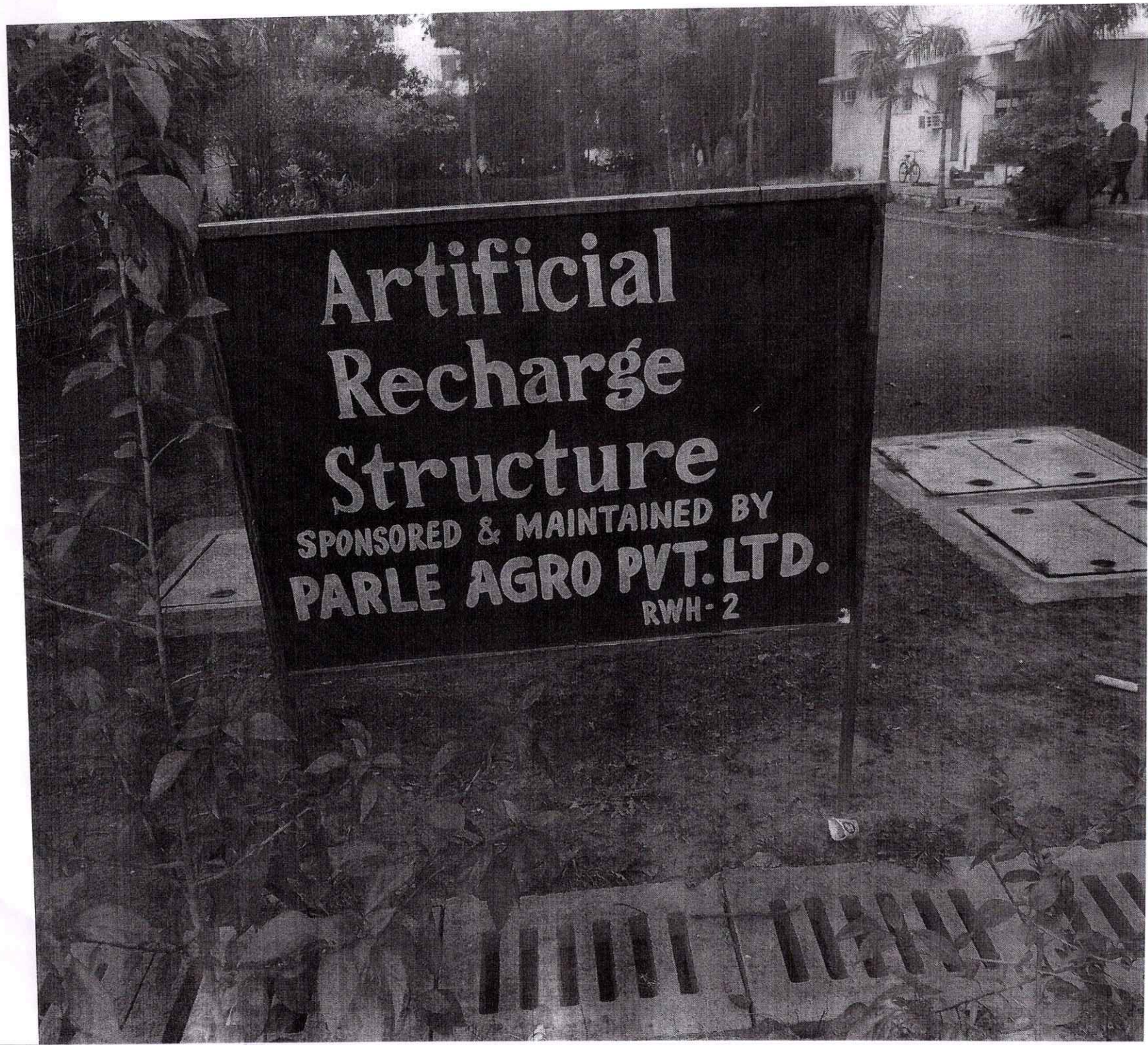

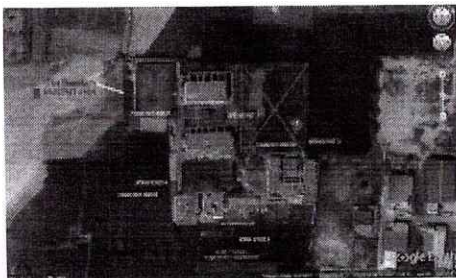
